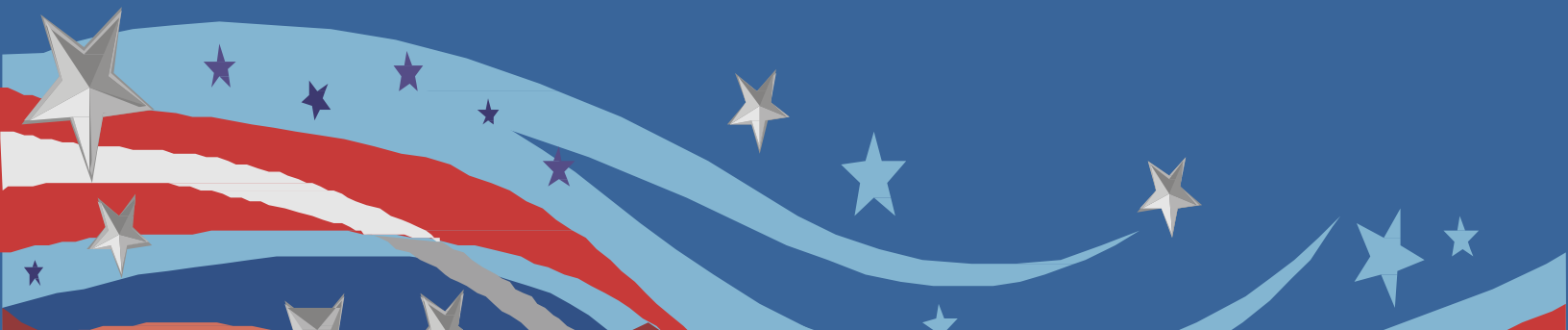

About the USO of Missouri, Inc.

- The James S. McDonnell USO, located on the lower level of Terminal 1 at Lambert-St. Louis International Airport, was established in 1981 and named for James S. McDonnell, founder of McDonnell Aircraft.
- Since 1981, over 5.4 million traveling military and their families have benefited from the services provided by the USO of Missouri, Inc.
- The Mobile USO unit program was added to the outreach efforts in 2005. The units travel throughout Missouri and the Illinois counties of Madison, Monroe, Jersey and St. Clair to take the services and the USO spirit straight to the troops.
- In mid 2006, the 18,000 sq ft. Ft. Leonard Wood USO was added to the services lines of the USO of Missouri.
- The Terminal 2 Satellite facility, located on the lower level of Terminal 2 at Lambert-St. Louis International Airport, was established in 2007 and made possible by the generosity of the Joan and Vern Wendt family.
- The USO of Missouri provides services and smiles to more than 275,000 military personnel and their families annually.
- The USO of Missouri and all outreach functions are governed by a board of directors and funded solely by the generosity of our donors.

USO Programs & Services

- The USO hosted Military Appreciation Day at the St. Louis Zoo serving over 800 military members and their families.
- The USO hosted quarterly Family Game Nights at Fort Leonard Wood serving over 2,500 military members and their families.
- The USO provided over 1,800 Thanksgiving Baskets to military families.
- The USO hosted it's Annual Santa's Express children's event serving over 1,200 military members and their families.
- The USO hosted Holiday Block Leave for over 4,500 military members traveling home for the holidays.
- The USO provided over 300 Holiday Goodie Bags for military members not traveling home for the holidays at Fort Leonard Wood.
- The USO provided United Through Reading recordings for military families.

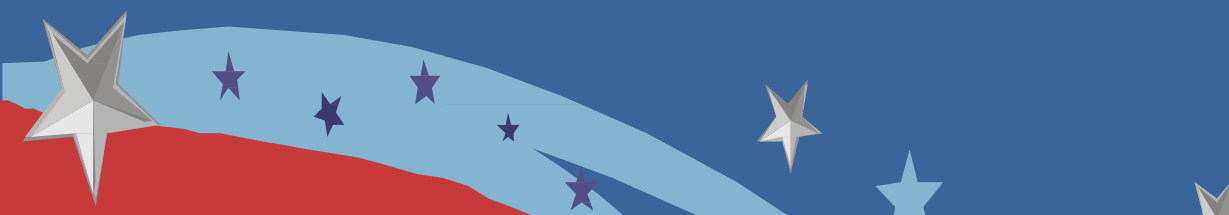
